## **Overview & Current Events**

Gladstone Investment is a business development company (BDC) that focuses on US-based small- and medium-sized companies. Industries which Gladstone Investment targets include aerospace & defense, oil & gas, machinery, electronics, and media & communications. The company was founded in 2005 and is headquartered in McLean, VA.

Gladstone Investment reported its second quarter (Q2 2024 ended September 30) earnings results on November 7. The company generated total investment income - Gladstone Investment's revenue equivalent - of \$22.6 million during the quarter, which represents an increase of 2% compared to the prior quarter. This was a better performance compared to the previous quarter, when the growth rate was negative.

Gladstone Investment's adjusted net investment income-per-share totaled \$0.24 during the fiscal second quarter. That was unchanged from the previous quarter's level. Gladstone Investment's net asset value per share totaled \$12.49 on a per-share basis at the end of the quarter, which was down compared to the NAV-per-share that the company reported at the end of the previous quarter. Gladstone Investment Corp. has seen its net investment income-per-share decline in 2023, but marginally higher profits are forecasted for the current year. Profits will likely remain below the high seen in 2022 during the current year, however.

## Growth on a Per-Share Basis

Gladstone Investment's net investment income per share can be a bit lumpy. During the Great Recession, the company's profits declined substantially, but Gladstone Investment remained profitable. Over the last decade profits grew by around 3% annually, which is not a very high growth rate, but which is also not at all disappointing for a high-yielding investment such as BDC Gladstone Investment.

Gladstone Investment's business model is relatively straightforward. The company lends money to small- and mid-sized companies. Position sizes for debt investments usually range from \$5 million to \$30 million. The company also takes equity stakes in some of its portfolio companies. The companies Gladstone does business with usually cannot access debt or equity markets directly, as bond sales and public listings are not possible for them due to their small size. Gladstone makes its money via spreads between the interest rates the company pays on cash that it borrows, and the interest rates it receives on cash that it lends -- the same principle as with banks. Interest rates can result in some ups and downs in the company's net investment income. In some years, Gladstone Investment has suffered from above-average credit losses, which is why we believe that there is a significant likelihood of earnings being somewhat lumpy in the future, too. In the long run, we expect earnings-per-share growth in line with the historic average.

Gladstone Investment has been valued at a low-double-digit price to net investment income multiple throughout most of the last decade. Today, shares trade at 14x net profits, using our estimate for the current fiscal year. We believe that multiple contraction will be a bit of a headwind for the company's total returns, since we expect that the company's valuation will compress over the coming years.

### Safety, Quality, Competitive Advantage, & Recession Resiliency



Gladstone Investment's dividend payout ratio, relative to its net investment income, has been close to or above 100% throughout parts of the last decade. The company sometimes is more profitable than the net investment income metric suggests, since Gladstone Investment can also generate gains from its equity investments, which are not reflected in the net investment income metric. The company nevertheless had to cut its dividend during the Great Recession, but a dividend cut was avoided during the pandemic.

Gladstone Investment's equity investment gains explain the company's long-term book value growth. Gladstone Investment's recession performance is not very compelling compared to less cyclical income stocks, but at least the company remained profitable during the last financial crisis, unlike many other financial corporations.

## Final Thoughts & Recommendation

Gladstone Investment is a business development company targeting small companies that do not have the ability to access debt and/or equity markets easily. This allows Gladstone to demand above-average interest rates. The company does not generate a lot of growth, but the high payout ratio allows for an above-average dividend yield. Right now, shares trade above fair value, which is why we rate Gladstone Investment a hold at current prices.
